What are cookies?

Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies are widely used by website owners in order to make their websites work, or

to work more efficiently, as well as to provide reporting information. Cookies set by the website/ application owner (in this case, Augmentia) are called "first-party cookies." Cookies set by parties other than the owner are called "third-party cookies." Third-

party cookies enable third-party features or functionality to be provided on or through the website (e.g., advertising, interactive content, and analytics). The parties that set these thirdparty cookies can recognise your computer both when it visits the website in question and also when it visits certain other websites. Cookies can be "Persistent" or "Session" Cookies. Persistent Cookies remain on Your personal computer or mobile device when You go offline, while Session Cookies are deleted as soon as You close Your web browser.
